The Chief Commissioner & Principal Coordinator, National Games Secretariat (NGS), invites manual tenders from reputed Agencies for the supply of the following items. Bids should be submitted at the NGS Office before 5:00 p.m on January 17, 2015.

### ***Items Required***

- A.** The items as per the minimum specifications required as detailed in **Annexure 3** are to be delivered at Games Village, Menamkulam, Thiruvananthapuram.
- B.** Bidders may quote for supplying the tendered items in part or in full. Please use the format for financial bid, provided as Annexure 1 to this RFP, to submit the bid.
- C.** The quantities indicated are indicative and orders will be placed as per the actual requirements.
- D.** NGS reserves the right to select more than a single supplier through this tender process. At least 50% of the order quantity shall be awarded to the L-1 Bidder and the NGS may distribute the remaining quantity among the L-2 and L-3 Bidders, subject to the condition that the other Bidders shall match the rate of the L-1 Bidder.

**Please note that brand names and specifications wherever mentioned are meant for guidance to the bidders. Any alternative product of an equivalent or higher specification may be offered.**

NGS reserves the right to vary the quantity to be purchased and also to purchase from more than one agency.

3. NGS may decide to purchase the required total number of water bottles meeting the minimum specifications given as Annexure 3, either 750 ml or 1000 ml capacity. NGS may also decide to purchase the required number as a combination of both capacities.

## **Appendix 1: Terms & Conditions**

1. **Document Fee:** The Bidder shall be required to remit a non-refundable sum of Rs. 2000/-, plus VAT @ 5% towards the cost of the Document Fee as a Demand Draft in favour of “CEO & Secretary, National Games Secretariat”, payable at Thiruvananthapuram. Any Bid that is not accompanied by the Document Fee, shall be summarily rejected.
2. **Earnest Money Deposit:** The bidders are required to send their tenders along with a Demand Draft of Rs.20,000/- (Rupees Ten Thousand only) drawn in favour of “CEO & Secretary, National Games Secretariat” payable at Thiruvananthapuram, as Earnest Money Deposit, which will be refunded to the unsuccessful Bidders on their written request. The Earnest Money of the Successful Bidder will be refunded upon submission of the Performance Security Deposit and award of work.
3. **Performance Security:** The successful bidder shall have to give performance security @10% (by way of Demand Draft) of the total amount quoted by the successful Bidder within 3 days from the date of receiving of the Letter of Award, which will be refunded after 30 days from the date of completion of the contract successfully and payment of last Bill whichever is later.
4. NGS reserves the right to not to follow up this RFP, modify the RFP process or terminate the entire RFP Process, without assigning any reason or without any obligation to any of the Applicants.
5. This RFP in no way forms any commitment or indication of any business from NGS. Submission of the RFP shall not guarantee an automatic selection or empanelment of the Applicant.
6. Each Applicant shall be liable to individually bear the cost of data collection, preparation and submission of this RFP.
